## Royal MTC announces Executive Director Camilla Holland to depart at end of 2023/24 season

Winnipeg, December 12, 2023 – Laurie Speers, Chair of the Board of Trustees, announces that Executive Director Camilla Holland will not be renewing her contract at the end of the 2023/24 season. In a long-planned transition, Camilla will leave in June 2024 after 13 years with Royal MTC, and the organization launches a search today for a new Executive Director.

Already a fixture in the Canadian theatre community, Camilla joined Royal MTC in 2011 and has been an empathetic leader, a passionate advocate of the arts, and has showcased her community-driven approach every step of the way. Royal MTC is deeply grateful for her dedication and we are excited to see what she does next.
